1 Introduction and purpose

This policy provides guidelines for the use of the Internet and social media and constitutes support for the board, leaders, players and others who posts comments on social.

The purpose is not to limit the use of social media, but avoid comments that give Telge United FF negative publicity.

1.1 Definitions

Definition	Description
Good practice	Good deeds; legal notion that is preferably used for such purposes is not recorded in written laws, but appears as informal norms. Good practice includes both the usual (common) and the ethically and morally correct within a professional circle, society, friendship, etc.
Social media	Social media mean websites and mobile applications (apps) with the help of which people can interact in social networks and, in contrast to traditional media, contribute to user-generated content. Social media can include internet forums, social networking services, blogs, wikis, podcasts and other comments.

2 Internet Policy

2.1 Guidelines

When using the internet, common sense should prevail due to the fact that electronic tracks are left on, for example, visited sites and that can in the long run be linked to Telge United FF in one way or another. Your username or signature can also be linked to Telge United FF in one way or another. This is especially true if you comment on, included but not limited to:

- Telge United FF's web site;
- Women's soccer in Stockholm web site;
- Another teams' web site;
- Other groups on Facebook.

Remember to be objective when posting comments. Telge United FF assumes that all communication on the Internet, which in some way can be linked to Telge United FF, follows good practice.

When you post to social media:

- You must not mock, bully, harass or threaten anyone;
- You may not publish content that is hateful, threatening, pornographic, or that calls for acts of violence;
- You must not participate or encourage any crimes.
